The advertisement for purchase of above mentioned articles during the year 2015-2016 was floated through Director Information (ADV) Government of Sindh Information Department Karachi, which was appeared in Daily Dawn Karachi dated: 13/03/2016, Daily Dunya Karachi dated 13/03/2016 & Daily Awami Awaz Karachi dated: 14/03/2016, floated on the website of SPPRA on 11/03/2016. Four (04) firms purchased tender documents, Two (02) firms responded and representatives of Two (02) firms were present at the time of the opening of tenders.

The above item is recommended for purchase during current financial year 2015-16, Director Animal Breeding Sindh Hyderabad is authorized to issue supply orders to approved firm and on approved rate.

- a. The firm will pay 17% sales tax or otherwise as admissible.
- b. The firm will have to pay income tax on the cost of Goats supplied.
- c. The firm is responsible to deliver the Goats within 15 days, after issue of the order failing which their supply orders may be treated as cancelled and order will be placed to 2nd lowest bidder.
- d. The Director Animal Breeding will follow rules of SPPRA.
- e. The Director Animal Breeding will place the orders within budget and release amount, no anticipatory purchases.
- f. The firm has to submit No Objection Certificate of professional tax from Excise & Taxation Department.
- g. Boer Goats will be accepted subject to provision of landing /shipment documents of Karachi Airport/Seaport, and Quarantine certificate from Animal Quarantine Department by the successful firm and will show physically said item at Airport Karachi / Sea port Karachi to representative of Livestock Department.
